**SESSION #2: Clery & Title IX: Partnering to Meet VAWA Disclosure Requirements in the Annual Security Report** (Adrienne Murray and Ann Todd)

This session will explore the importance of meeting the Clery Act (VAWA) requirements in Title IX and non-Title IX policies that pertain to the intake and resolution of sexual assault, dating violence, domestic violence, and stalking reports. The session will also provide guidance on ensuring the institution's ASR accurately and compliantly reflects the required language.

**SESSION #3: Obtaining Information and Sharing Information: Campus Security Authorities under the Clery Act and Mandated Reporters under Title IX** (Cathy Cocks and Michael DeBowes)

Pre-2020 Title IX regulations, the guidance regarding who institutions should identify as "Responsible Employees" under Title IX was broad, and in some ways, more clear. The 2020 Title IX Regulations only identify Title IX Coordinators and any official of the recipient who has authority to institute corrective measures. This session will explore the reporting obligations of Title IX "reporters" as well as the requirements for Campus Security Authorities under the Clery Act and offer practical guidance on identifying, training, and receiving reports from both groups.

**SESSION #8: Its January in a New Clery Year...What Should I Be Doing?** (Michael DeBowes and Dolores Stafford)

October 1 has passed, but so has January 1! That means there are key tasks that Clery Compliance Officers need to fulfill for both the previous calendar year and the current year. This session will review the most pertinent tasks on which to focus including issues related to Clery Geography, crime and fire statistics, CSAs, and more.

**SESSION #9: The Use of Race and Sex/Gender in Timely Warning Notices** (Jillian Paciello and Tabitha Smith)

In a time of increased awareness of identities on campus, this session will explore the pros and cons of identifiers such as race and sex (gender) in TWNs. Focus will be on if, when, and how institutions could (or may choose not to) use such identifiers as well as provide suggestions for more inclusive prevention language for inclusion in public disclosures.

**SESSION #10: Minors on Campus: Title IX and Clery Act Compliance Issues** (John Ojeisekhoba and Adrienne Murray)

The presence of minors on campus has increased beyond the summer camps and conference programs many campuses traditionally hosted just in June and July each year. Minors frequently attend classes, conduct research, participate in institution-sponsored programs and activities, and live on campus. This session will discuss the relevant Title IX and Clery Act implications of minors on campus and will provide tips for creating an appropriate Minors on Campus policy.
